Communications is Key¹



You must communicate before, during and after what the institution's fundamental mission is and how it aligns to the greater good of the employees and organization.



Cultivate Resilience⁴

Cultivating resilience in employees is essential. Communicate a message of optimism. Offer programs for employees to support them. Celebrate stories of resilient employees.

Lead by Example²



As a leader, you must demonstrate the values that represent the organization and identify the behaviors that show employees you value them on a daily basis.



Be Visible⁵

Leaders need to be seen by all employees through: periodic in-person check-ins, full transparency, continuous communication and offering open two-way communication.

Employees First³



Leaders must convey a genuine and consistent concern for all employees. If employees believe that a leader is concerned for them, this will cultivate resilience.



Behaviors Set the Tone⁶

Identify and exhibit fundamental personal values that you live every day. Make yourself and others accountable for those behaviors. The organization can add them to performance reviews.
